

2019 Educational Programming Benefit Raffle Official Rules and Regulations

These are the Official Rules and Regulations to govern Shelburne Museum's 2019 Educational Programming Benefit Raffle.

- 1. **Prize –** Raffle prize is a Queen-sized batik quilt hand-crafted in Vermont.
- 2. **Tickets** Each ticket can be purchased for \$5.00 (Five US Dollars). A block of 5 (Five) tickets can be purchased for \$20.00 (Twenty US Dollars).
- 3. **Drawing -** The raffle prize drawing will be held on Friday November 1, 2019 at 3:00 p.m. Eastern Time at the Shelburne Museum Store located at 6000 Shelburne Road, Shelburne, VT 05482. The winning ticket will be drawn at random from a box containing all eligible raffle tickets. The drawing of the prize is open to the public; however, the winner does not need to be present to win.
- 4. How to enter Tickets may be purchased until Thursday, October 31, 2019 at 5:00 p.m. Eastern Time (except as noted below). Tickets can be purchased as follows:

- 5. Qualified participants Purchasers of raffle tickets must be 18 years of age or older and a resident of the United States. The winner must supply their social security number (for tax reporting purposes only) and all other documentation required to receive the winning prize. Employees of Shelburne Museum and their immediate families are not eligible to participate in the raffle.
- 6. **Timing** The winners of the raffle must claim the prizes within 30 (thirty) days of the drawing. If the winner does not claim the prize after 30 days of the drawing, winner forfeits the prize and an alternate winner will be selected randomly from the remaining tickets.
- 7. **Delivery** If the winner is not able to pick up the quilt in person, Shelburne Museum will ship the item within the continental United States. International shipping costs or costs of shipping outside of the contiguous United States will be incurred by the winner. The quilt will be received in "as is" condition.
- 8. **Lost tickets** Shelburne Museum is not responsible for lost tickets or misdirected mail.
- 9. **Acceptance of Official Rules and Regulations** By participating in this raffle, all ticket purchasers accept and agree to be bound by all the rules, limitations and restrictions set forth herein.
- 10. Legal Shelburne Museum does not provide legal or tax advice on the consequence of the raffle or its winner. Federal and State laws provide that the winner must pay all taxes on the value of their prize including income taxes. The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings are not considered gifts and consequently do not qualify as deductible charitable contributions. Quilt winner is responsible for all licensing, registration, transfer, title or sales tax and fees and other expenses not specified herein as the obligation of Shelburne Museum. Subject to all federal, state and local taxes, laws and regulations. Void where prohibited.

These terms and conditions and any matters relating hereto shall be governed by and construed in accordance with the laws of Vermont and jurisdiction over any and all disputes shall be exclusive to the state and federal courts in Vermont.
